Report from the Department of Civil Litigation

The Civil Litigation and Public Law Department of the Federal Ministry of Justice functions include:

- Provision of legal representation in civil matters affecting the Federal Government, Extra Ministerial Department and Agencies.
- Provision of legal advice to the Ministries, Department and Agencies of the Federal Government.
- Provision of legal opinion in matters arising from Federal Government Polices and particularly as it relates to implementation.
- Initiation of court action to assert public right.
- Representation of the Federal Government's interest in crucial meetings likely to affect government policy.

In addition, the Civil Litigation Department:

- Co-ordinates the Civil Litigation Units in the various Zonal offices of the Ministry and Legal Units of Federal Ministries and Agencies.
- Co-ordinates and monitors private legal practitioners who have the fiat (letter of instruction) of the Honourable Attorney-General of the Federation to institute and defend civil suits on his behalf.
- Participates in Alternative Dispute Resolution matters and Arbitration to protect the interest of the Federal Government.
- Collates and monitors pending sensitive cases in the different hierarchies of Courts, and present same to the Honourable Attorney-General.

Overview of Activities

The period under review (29th May, 2015 to 10th March, 2017) witnessed heightened litigations in various courts namely the Federal High Courts, State High Courts, the National Industrial Court, ECOWAS Community Court, Court of Appeal and the Supreme Court.

The Ministry received and handled between 29th May, 2015 to 10th March. 2017, a total of **974 civil cases and 167 appellate matters** were handled by the Department.

These cases include: Land Matters, Contract maters, Fundamental Right matters,

Labour/Trade Union matters, Employment related matters, Constitutional matters, Garnishee proceeding matters, Arbitration matters, Electoral matters and action initiated in the ECOWAS Community Court.

The Department was able to conclude **84 matters** out of the **357 matters** referred in 2015; while **17** were concluded out of the **167 appellate matters** received by the Department from 29th May, 2015 till 10th March, 2017. The remaining are in different stages of appeal before the appellate Courts.

Most of these concluded matters were decided in the government's favour and the ministry was able to save huge amounts in claims against the government.

Civil Cases Farmed out

Owing to economic down turns, the Ministry farmed out only 2 cases to external solicitors, while the remaining 1139 (inclusive of the appeal matters) were efficiently and robustly handled in-house by the Legal Officers in the Civil Litigation and Public

Law Department of the Ministry.

Cases resolved through ADR mechanism

The Department identified ADR as an important way of improving access to justice. Mechanisms are usually cheaper, faster and easier to use than the traditional courts. During the period under review, the department engaged in several ADR proceedings both for the government, the Ministry and for other MDAs. Some of these interventions led to the amicable resolutions of cases which involved huge monetary claims against Government.

Legal Opinions

Rendering Legal opinion to MDAs is one of the major mandates of the Department. These include petitions, complaints, etc from persons and institutions seeking the HAGF's intervention on a diverse range of legal matters. These opinions usually minimize conflicts between parties that would otherwise evolve into litigation.

During the period under review, the Department received and successfully proffered **1002 legal opinions** to different persons and MDAs.

Challenges

The current budget for the Department is a major challenge. There is Inadequate funds available to the department to enable it discharge its enormous responsibilities. In addition to this is the difficulty in securing appropriated funds timeously. This has had practical implications on the activities of the department. There is also the challenge of limited basic infrastructure like photocopiers and computers. All these prevents the department from giving efficient and effective service.

Other Challenges include:

Inadequate working tools and materials: Current Law Reports, reference matt up-todate Departmental Library and internet facilities are the tools to successful litigation in court.

Lack of utility vehicle: The department being litigation oriented, requires Utility Vehicles to take lawyers to and from court. Lack of this essential facility is affecting the morale and output of lawyers in the department since they sometimes have to attend court sitting in far-flung places at the periphery of the FCT.

Training of legal officers: There is need for regular training of staff in the department so as to enable them acquire improved skills and adapt to modern techniques in advocacy and other areas relevant to the operations of the department, particularly 1 in the area of arbitration. For instance, the legal officers of Civil Litigation and Public Department did not attend any training for the year 2015 and there the practice of consistent training of the legal officers of the department.

Specialized training for registry staff: Litigation clerks require specialized trains court related procedures and matters to heighten response to matters particularly processes.

Consistent delay or non-response in briefing the office of the HAGF by relevant MDAs

to ensure effective and timeous representation of government and its agencies in legal actions. This development may also explain why the Department /Ministry have to incur debilitating expenses on penalty fees, particularly, Federal High Court and the National Industrial Court.

Protection of legal officers handling sensitive matters: With no less than a hundred personnel in the Department (where only forty-five existed as at 2013), the pressure on office space, working tools and equipment has obviously become a consistent challenge.
