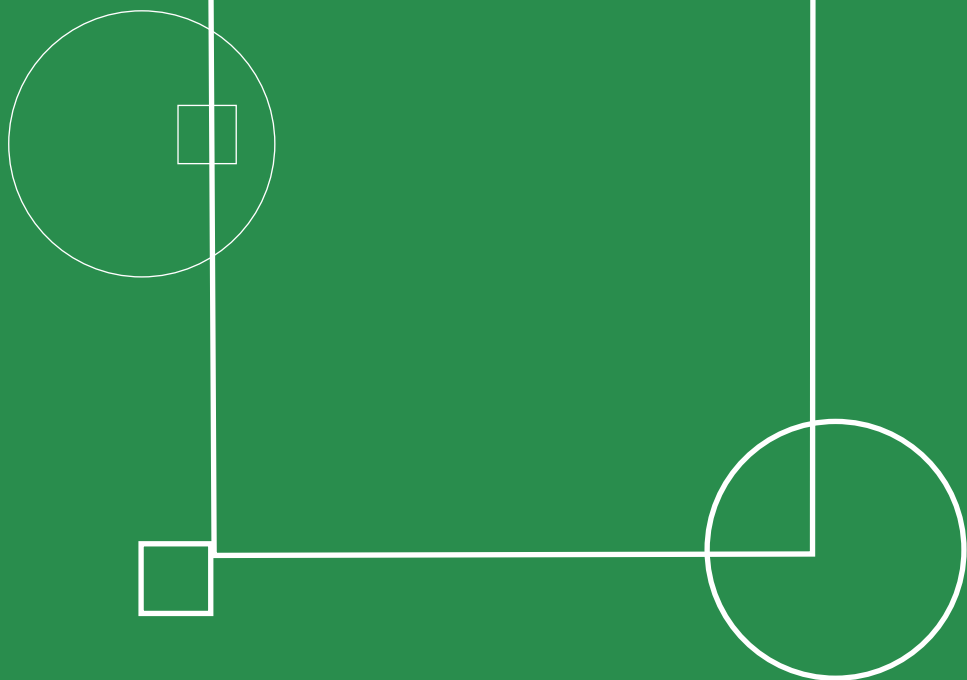

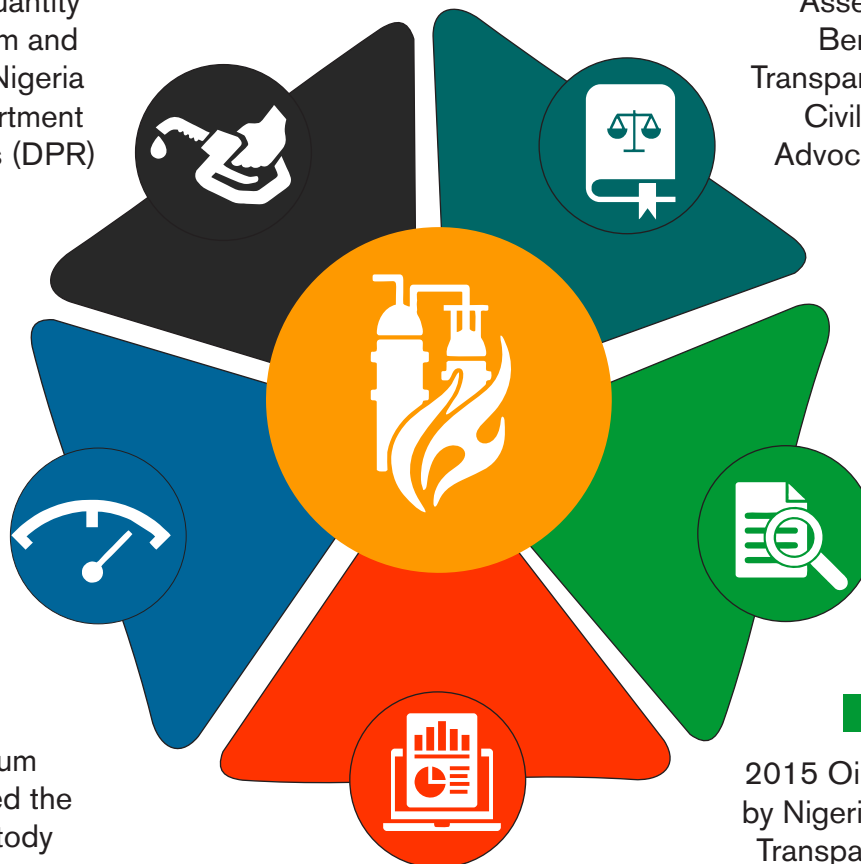

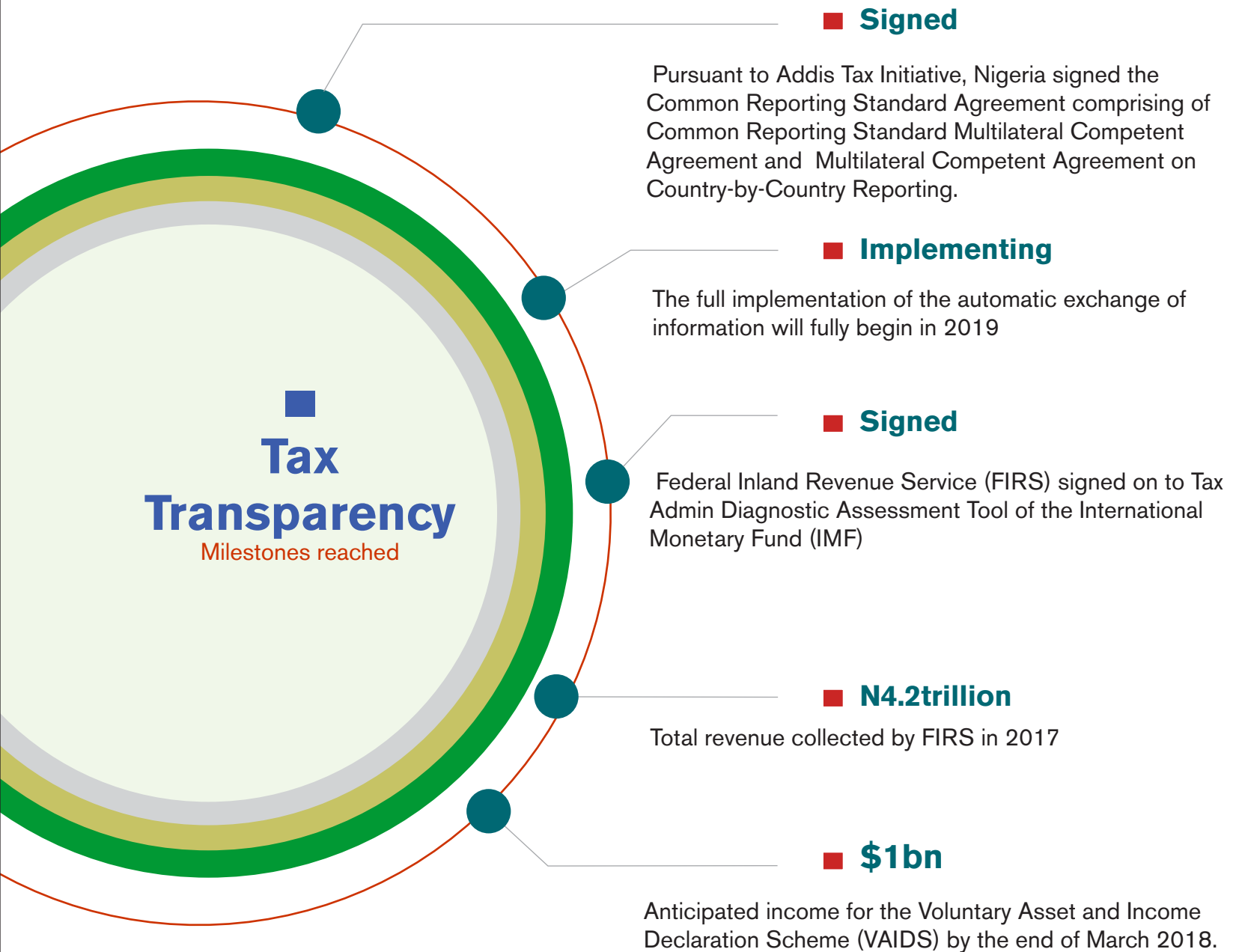

Anti-Corruption



The Asset Recovery Management Unit was set up in the Ministry of Justice. The Unit doubles as the secretariat for the implementation of National Anti-Corruption Strategy



The Proceeds of Crime Bill was passed in the Senate. The bill is going through Legislative process in the House of Representative.



ANEEJ published a CSO report on Asset Recovery ahead of the Global Forum on Asset Recovery in December 2017 in Washington DC.



A framework for CSO monitoring of the procedure for recovery and utilization of recovered assets was included in the agreement with the Swiss Government on return of Abacha loot and in the National Anti-Corruption Strategy document.



A central account opened with the Central Bank of Nigeria for local and international asset recoveries.



An audit committee set up by the President is currently verifying recovered asset and the audit report will be made public.



The Whistleblowers Bill was submitted to the National Assembly for passage and the Federal Executive Council approved the Whistle blower policy which is managed by the Federal Ministry of Finance.



A government team from CAC, NEITI, Federal Ministry of Justice and OGP Secretariat undertook a study of the UK Beneficial Ownership Register



CAC proposed a bill to repeal and re-enact the Corporate And Allied Matters Act (CAMA) Bill, The bill will establish Beneficial Ownership Register with a database managed by CAC and integrated with data from BPP, NEITI and FIRS.
