On his part, the Executive Secretary of the National Human Rights Commission (NHRC), Tony Ojukwu, noted that Apata is a good person. He described him as a wonderful person and prayed that it would be well with the Retiring Permanent Secretary. The climax of the event was the cutting of cake for Apata's 60 years birthday anniversary. He retires from the Civil Service of the Federation on Sunday, having clocked 60 years.
